This matter was tabled at the Archaeology, Palaeontology and Meteorites (APM) Committee meeting held on 30 July 2024. ECPHRA acknowledges the NID payment of R500 and the LoR (Letter of Exemption dated 2016 compiled by C.Booth which is based on an adjacent mine).

ECPHRA has noted that this is a new section of the farm that would be mined therefore it needs its own Heritage Impact Assessment (an AIA & PIA) and proof of R1 500 payment to be forwarded to ECPHRA or attached to the case on SAHRIS.
