1. INCORPORATED PROVISIONS

The Supplier warrants that it has a legal agreement with the owner of property on which the Quarry Site is located and Access Routes and that it has the legal right to grant access to the site to the Contractor.

2. INSURANCE AND RISK

Ugie Mac Quarry shall affect and keep in force during all material times insurance for his equipment and any other risks he deems fit over the life of the Agreement. The Landowner indemnifies and shall hold harmless the Contactor for any injury or claims suffered by any party as result of and flowing from the quarry operations by the Contractor.

3. SUPPLIER'S PRICE

The compensation paid for access to the quarry material (hereinafter referred to as "the Supply Contract Price") shall be the sum named in Annexure "A" hereto or such other sum as shall become payable by reason of access to the quarry site and calculated with reference to the measured material excavated, and any authorised variations or other adjustments in accordance with the provisions of this Agreement, will be at landowners cost. After the intial 300 000 ton crushed for TAU Pele the cost payable per ton will be relative to the cost per ton at the Ugie Mac Quarry. The cost payable per ton will be set for a period of 5 years thereafter renegotiated to a reasonable increase in royalties no more than inflation rate. The

4. MONTHLY PAYMENTS

a) The Contractor shall, unless otherwise agreed to in writing or as provided for in this Agreement, make monthly payments to the Landowner for the amount which at the date thereof fairly represents the value of the material sold, for the month in question. Such application shall be submitted to the Contractor on the 30th day of each month.

REMEDIES OF DEFAULT

- If the Landowner is in breach of any of his obligations under this Agreement, a) including and without limiting the a foregoing, if he denies unhindered access to the designated quarry area or access routes to the Contractor, his servants or agents,
- and fails to remedy such breach within 5 (five) days after written notice from b) the Contractor; or
- if the Landowner estate is sequestered or if it is placed in voluntary or C) compulsory liquidation or under judicial management or if the Landowner effects a compromise or compound with his general body of creditors or if any of his assets are attached pursuant to warrant or execution issued by any Court of Law, or if he commits an act of insolvency; then the Contractor shall be entitled, without prejudice to any other remedy he may have, to forthwith terminate the employment of the Landowner and recover from him any damages, losses or expenses incurred by the Contractor.
- If the Contractor fails to perform any act under this agreement on the due d) date thereof, The Landowner shall be entitled to cancel this agreement, close of all access to the quarry to bar the Contractor from entering his property and claim from the Contractor any damages sustained by the Landowner due to its failure to perform in terms of the contract. The Landowner will give the Contractor written notice of such a default and 14 days to rectify the default, prior to any of the above-mentioned actions being taken.

7. SPECIAL PROVISIONS

a) <u>Programming</u>

The Landowner warrants its acceptance that, should the Contractor's requirements so dictate, the loading and transport of the material sourced from the quarry may be carried out on a 24 hour/day basis, 365 days of the year – Except on Sundays, unless otherwise discussed and agreed upon and permission is granted from the DMR. But normal working hours will be 7-5 week days unless stipulated above.

b) Details to be Confidential

The Landowner and Contractor shall treat the details of this Agreement, as a whole, as private and confidential and shall not publish or disclose any particulars to any third party unless with prior agreement with the other party.

c) Validity of Contract

 This Agreement shall remain in full force and effect until all claims of the Contractor against the Landowner have been determined and *vice versa*.
 For the duration of the 10 years Contract.

Rehabilitation of the guarry area and access routes

The Contractor warrants that all rehabilitation works, including but not limited to any environmental requirements as may be prescribed under the Laws of the Republic of South Africa, together with any amendments thereto, and any applicable municipal by-laws and/or regulations of local or other authorities as may be applicable, shall be the responsibility of the Contactor.

DISPUTES

ECPHRA (Eastern Cape Provincial Heritage Authority) COMMENT in terms of Section 38(8) of the National Heritage Resources Act (25 of 1999).

This matter was tabled at the Archaeology, Palaeontology and Meteorites (APM) Committee meeting held on 30 July 2024. ECPHRA acknowledges the NID payment of R500 and the LoR (Letter of Exemption dated 2016 compiled by C.Booth which is based on an adjacent mine).

ECPHRA has noted that this is a new section of the farm that would be mined therefore it needs its *own* Heritage Impact Assessment (an AIA & PIA) and proof of R1 500 payment to be forwarded to ECPHRA or attached to the case on SAHRIS.

The development outline is on a high sensitivity location hence a paleontological assessment is required. Applicants need to take note that the screening tool is based on historical data.

Note: HIA studies older than five years are not accepted by ECPHRA. HIA studies must be done on the study site in question. The HIA must include all associated development aspects such as relevant portions of the access road (s), site camp and laydown areas. This should be submitted for an HIA Comment in terms of Section 38(8) of the NHRA of 1999.

Specialist studies should be conducted by qualified professions in the relevant disciplines. AIA's by professionals with a minimum of an Honours degree and the PIA's by professionals with a minimum of a Masters degree.






