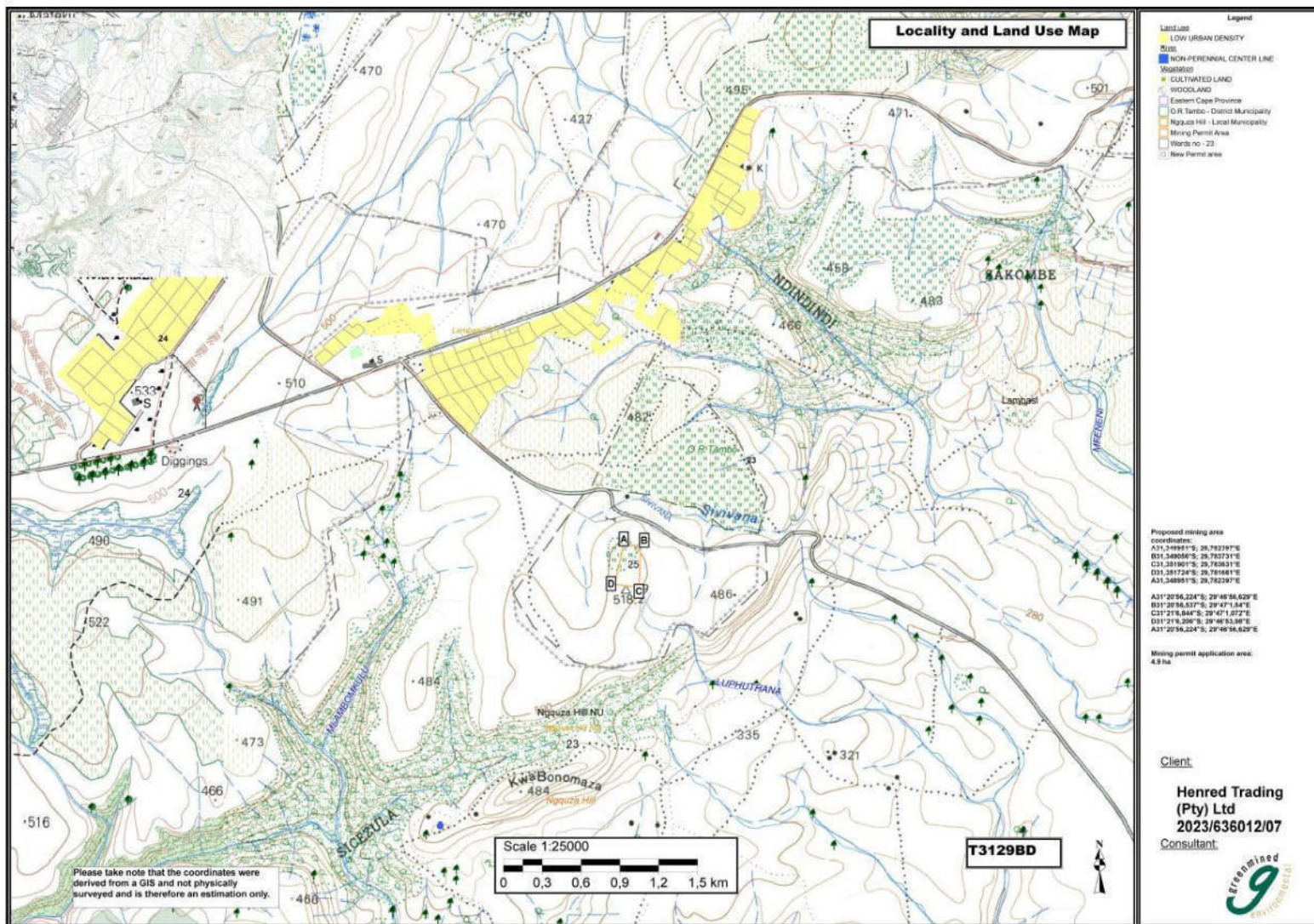

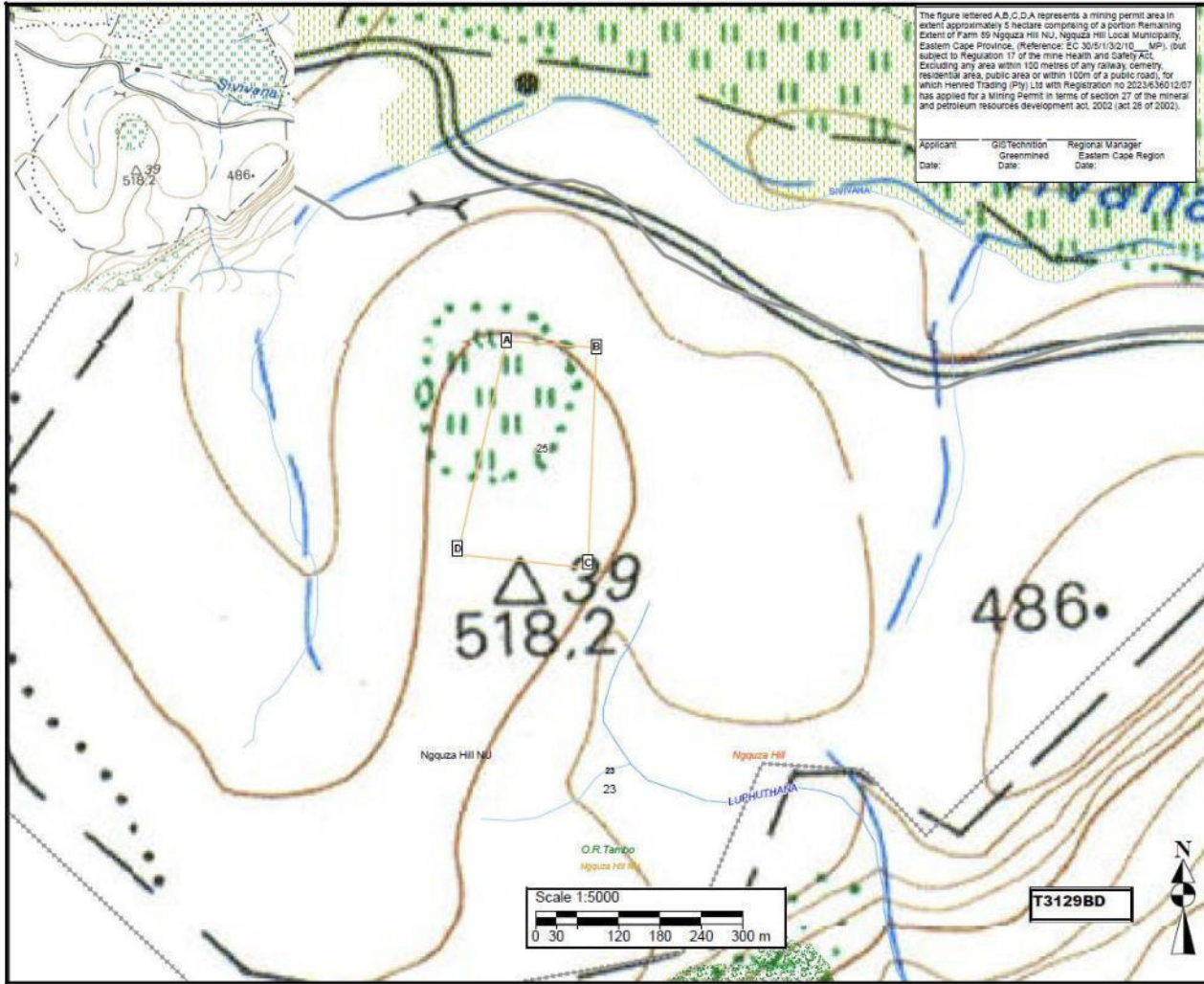

Our previous offer dated 11 September refers.


By way of this document we would like to restate it as:

- The stone drilled to date is of acceptable quality for the construction of the new N2 road.

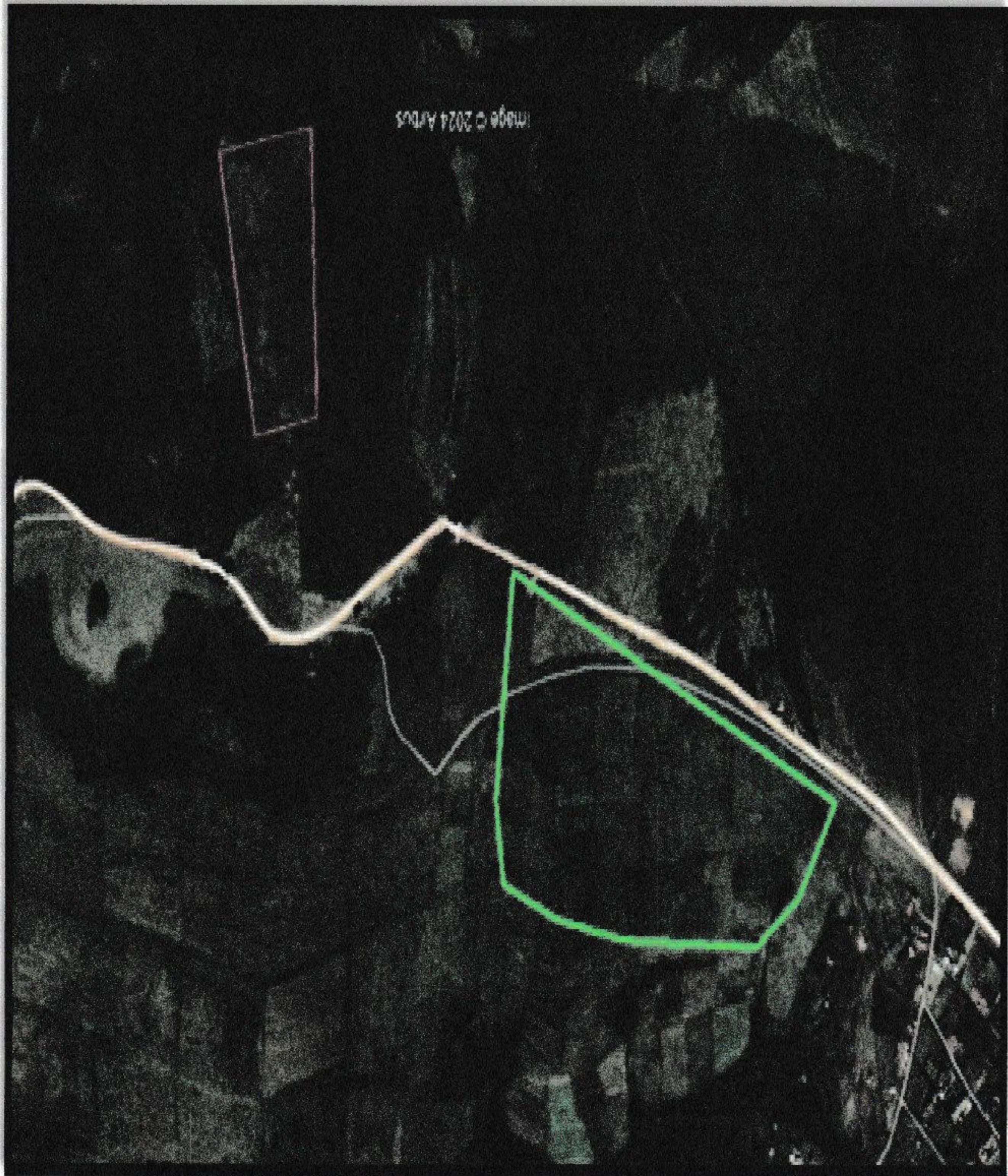

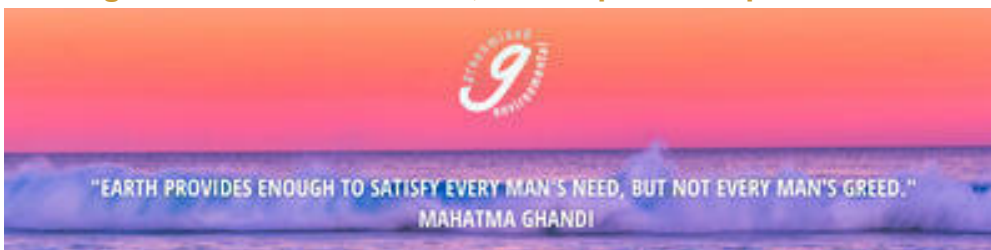

Your report received 20 May 2024 on the above matter, refers.

The South African Roads Agency SOC Limited (SANRAL) has the following comments with regards to the above:

- No structure shall be erected closer than 30 metres from the national road reserve fence and 500 metres from any point of intersection.
- If access is required from the National Road R61, an approval from SANRAL is required, otherwise access can be obtained from the nearest existing access, which SANRAL must be consultant for approval of the upgrading of the existing access, as the proposed mining will have impact on the traffic on the National Road.
- The developer will accordingly be required to establish and maintain a pedestrian proof brick/concrete wall along the full extent of the proposed mining to prevent pedestrian access onto the R61.
- Only where drainage crosses the boundary wall, a non-solid boundary is accepted. Any future negative impacts in this regard will be considered to be the responsibility of the developer to correct.

- SANRAL shall not be held liable should it be found at any future time that noise emanating from the national road, presents a problem in the development adjacent to the national road.
- All storm water discharged or diverted from the national road shall be received and disposed of. A drainage plan has to be submitted to this office for consideration.
- No advertising shall be directed or displayed to be visible from the national road during the development or construction of this proposed mining. All advertising shall be subject to SANRAL's approval.
- A formal application for the proposed development (mining) together with the plans of the proposed mining must be submitted to SANRAL for approval.
- Construction of all works may only commence after a written approval has been obtained by SANRAL.

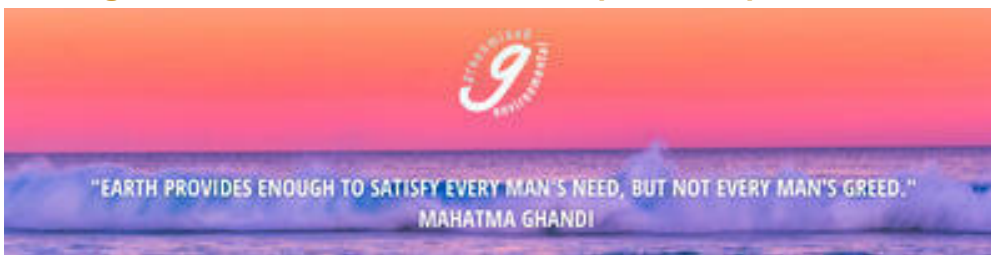

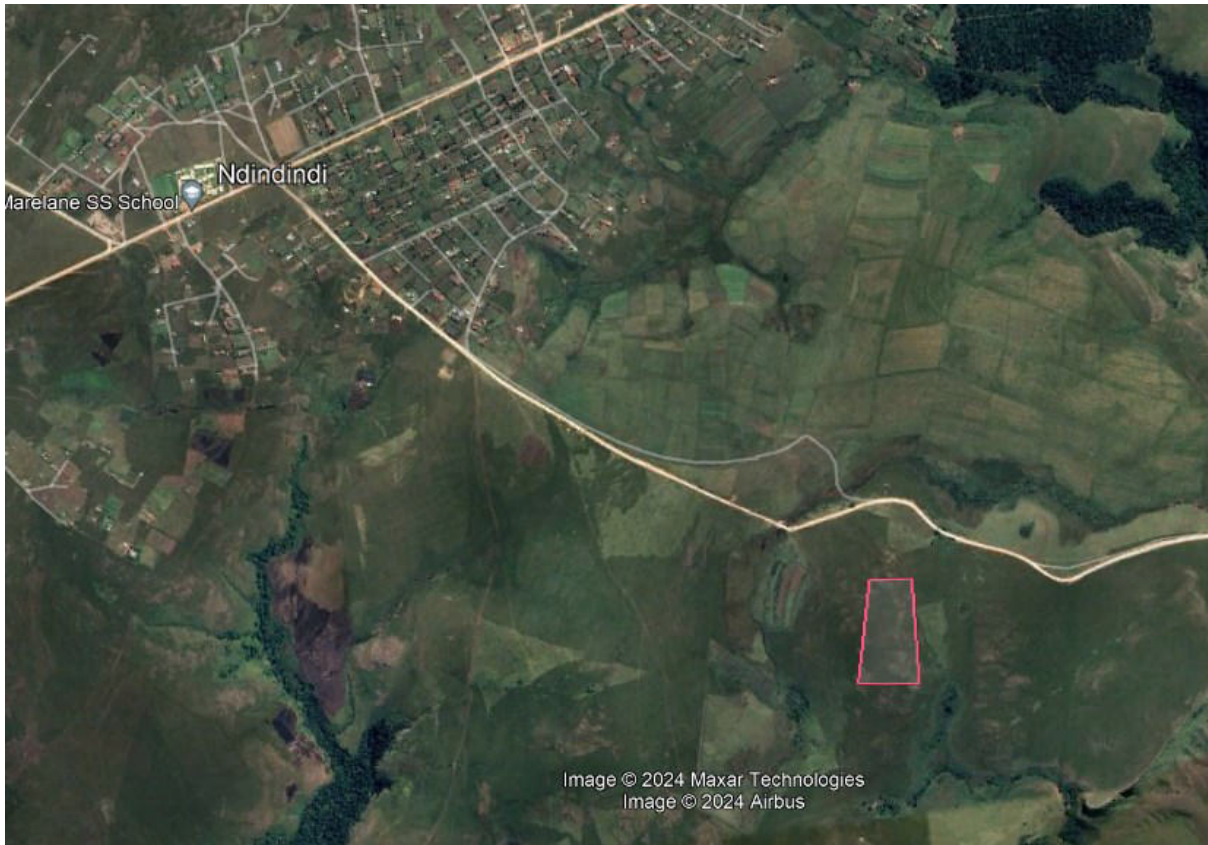


Figure 1: Imbonakalo yesathelayithi yendawo ecetywayo yemvume yokwemba (ipolygon epinki) yeHenred Trading (Pty) Ltd (umfanekiso ofunyenwe kuGoogle Earth).

- ❖ Indawo iyonke isikelwe imida ngokwejoloji yayo—yakhiwe ngelitye eliqinileyo, elimhlophe, elirhabaxa, i-siliceous quartz arenites (amatye entlabathi) yeMsikaba yeXesha le-Devonian (Thomas et al. 1992) ivelisa isondlo esingekho nzulu, esinesondlo- ihlwempu (evundiswe kakhulu), inamathambo, umhlaba onesanti eneasidi. Phantse i-80% yendawo ihlelwa njengodidi lomhlaba we-Fa, ilandelwa yi-Aa uhlobo lomhlaba (10%).
- ❖ NgokweNgxelo yoVavanyo lwesakhono soMhlaba kunye neZolimo (Isihlomelo M), lo mgodi ucetywayo uya kuba neempembelelo ezishiyekileyo ezisezantsi kumandla emveliso yezolimo emhlabeni. Oku kungenxa yokuba uninzi lwesiza lunomhlaba onesakhono esiphantsi, ezifana neGlenrosa kunye neMispah ezinobume bomhlaba obunyiniweyo ezithintela iprofayile yogcino lwamanzi, ukungena komoya, kunye nokukhupha amanzi, kwaye akukho masimi esityalo asebenzayo nokuba kuphantsi kwemeko yonkcenkcesho okanye imvula. Ngoko ke, luluvo lwengcali lokuba, uphuhliso olucetywayo lunokuqwalaselwa ngendlela efanelekileyo kunye nokuphunyezwa kwemilinganiselo yokunciphisa ukuqinisekisa ukwenzeka kweempembelelo ezibalulekileyo ezishiyekileyo ezilindelekileyo.

I-Hydrology:

- ❖ Iiyunithi ezine zemigxobhozo ezichazwe njengezi; imijelo emibini yentlambo-ezantsi (HGM 1 & HGM 2), iindawo ezimanzi ezininzi ezingenayo intlambo-ezantsi (HGM 3) kunye ne-hillslope seep enye (HGM 4).
- ❖ Akukho migxobhozo okanye imijelo yamanzi ichongiwe phakathi kwesicelo.
- ❖ Isithinteli sasemva kokuthomalalisa esi-20 m siyacetyiswa kwiHGM 1.
- ❖ Uphononongo lomgxobhozo luka-2024 lugqibe ekubeni akukho ziphene zibulalayo zibonakalayo kwiprojekthi ecetywayo okwangoku ngokunxulumene nemithombo yamanzi ahlaziyekileyo.

- ❖ Luluvo lweengcali ukuba iprojekthi leyo inokuqwalaselwa ngokuncomekayo ukuze igunyaziswe, phantsi komqathango wokuba onke amanyathelo amiselweyo okunciphisa ayaphunyezwa.
- ❖ Oku kubandakanya uthintelo lweendawo zokuhlala ezibuthathaka zamanzi acwengileyo kunye, ukucuthwa kophuhliso kule mimandla kwimeko yeziseko ezingundoqo ezifana neendlela zokungena.
- ❖ Isicelo sokusetyenziswa kwamanzi ngokoMthetho waManzi weSizwe, 1998 (uMthetho onguNombolo 36 ka-1998) siyaqhubeka ngoku.

I-Terrestrial Biodiversity (kuquka iFauna neFlora):

- ❖ Ngokwengxelo yeTerrestrial Biodiversity Assessment eqhutywe yiBiodiversity Company (Pty) Ltd, yomhla kaMeyi 2024 ehlonyelwe njengesihlomelo M2, iimpembelelo eziphambili ezilindelekileyo zeprojekthi ecetywayo iya kuba kukulahleka kwendawo yokuhlala, izityalo zeSCC kunye nokufuduka kwezilwanyana. Ngokusekwe kwiziphumo zomiselo lwe-SEI, i-PAOI ine-SEI 'ePhezulu'.
- ❖ Oku kuthetha ukuba uthintelo lothintelo naphi na apho kunokwenzeka kufuneka luphunyezwe.
- ❖ Oku kuquka utshintsho kuyilo lweziseko ezingundoqo zeprojekthi ukunciphisa ubungakanani bendawo yokuhlala echaphazelekileyo.
- ❖ Ngenxa yobukhulu obuncinci be-PAOI (5 ha) kufuneka zonke iziphumo zomda zilawulwe ngokuphumeza amanyathelo othomalaliso akhankanywe kule ngxelo, kukongezeleka kokubaluleka kwempembelelo yokuthomalalisa emva kokunxulunyaniswa neprojekthi ecetywayo kuthathwa njengokuphantsi.

Izilwanyana:

- ❖ Inyaniso esisiseko ibonise ukuba uvakalelo oluphezulu lwezilwanyana (isixhobo sokuhlola i-DFFE) sasichanekile ngenxa yokuba kufutshane nemimandla yasezidolophini uluntu lwezilwanyana luye lwachatshazelwa kulo kwiminyaka engaphambili.
- ❖ Akukho SCC yezilwanyana irekhodiweyo, nangona kunjalo inani elikhulu lezilwanyana ezanyisayo, i-avifauna kunye neentlobo ze-herpetofauna ekulindeleke ukuba zenzeke kummandla, kwaye uhlobo lwexesha elide lwexesha elide luya kufuneka ukuze kuqinisekiswa iisampulu eyaneleyo.
- ❖ Akukho siphene sibonakeleyo sibulalayo esinokuthi sithintele olu phuhliso ekugunyazisweni ukuba amanyathelo othomalaliso kunye nokuhlola acetywa yingcaphephe aphunyezwe nguMfaki-sicelo.

Imekobume yeNkcubeko neLifa leMveli:

Akukho ziza ze-archaeology, zakudala, okanye inkcubeko ebalulekileyo kwindawo yophando.

Iziseko ezingundoqo ezikhoyo:

Ukuba amanyathelo okuthomalalisa acetywayo kolu xwebhu ayaphunyezwa iziseko ezingundoqo ezikhoyo kwiifama/iipropati ezisebumelwaneni azisayi konakaliswa.

Ngaphandle kokuba amanyathelo okunciphisa kunye neenkqubo zokuhlola ziphunyeziwe, akukho ziphene ezibulalayo zinokuchongwa ezithintela umsebenzi ukuba uqhubeke. Isixamali sobonelelo lwemali esiya kuba yimfuneko ekuvuseleleni umsebenzi yi-R 511,618.78
