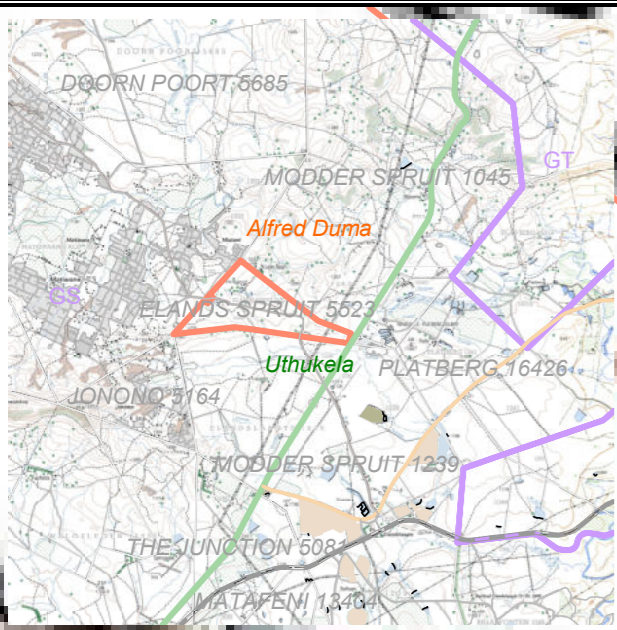

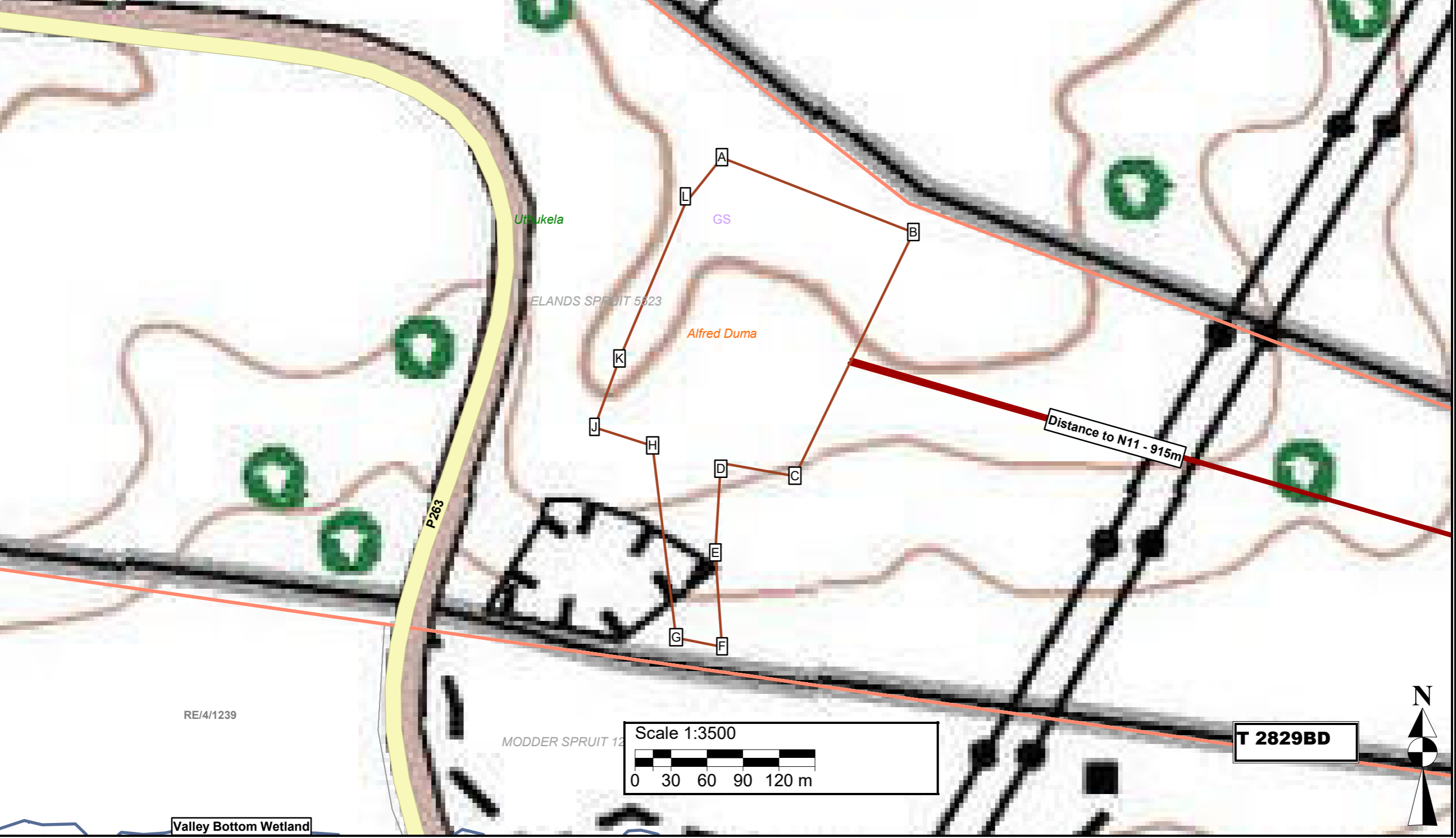
REGULATION 2.2 MAP

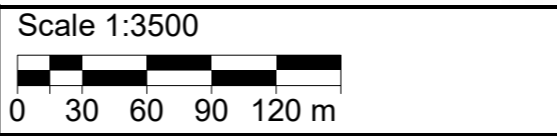

REQUEST INFORMATION ON PROPERTY: LAND CLAIM

We acknowledge receipt of your enquiry received on 4 April 2024.

We confirm that at the date of this letter, no land claims appear on our database in respect of the property described as **a portion of the Remaining Extent of the farm Eland Spruit 5523**. This includes the database for claims lodged by 31 December 1998 and those lodged between 1 July 2014 and 27 July 2016 in terms of the provisions of the Restitution of Land Rights Act, 22 of 1994 (as amended).

Whilst the Commission takes reasonable care to ensure and verify the accuracy of the information it provides, there are various factors that are beyond the Commission's control, particularly relating to claims that have been lodged but not yet published in the relevant government gazette, such as:

1. Some claimants refer to properties they claim dispossession of rights in land against, using historical property descriptions which may not match the current property description; and
2. Some claimants provide the geographic description of the land they claim without mentioning the actual property description against which they are claiming dispossession of rights in land.

The Commission therefore does not accept any liability whatsoever if through the process of further investigation, it is found that there is in fact a land claim in respect of the above property.

If you are aware of any change in the description of the above property after 19 June 1913, kindly supply us with such description (historic and current) so as to enable us to do a further search.

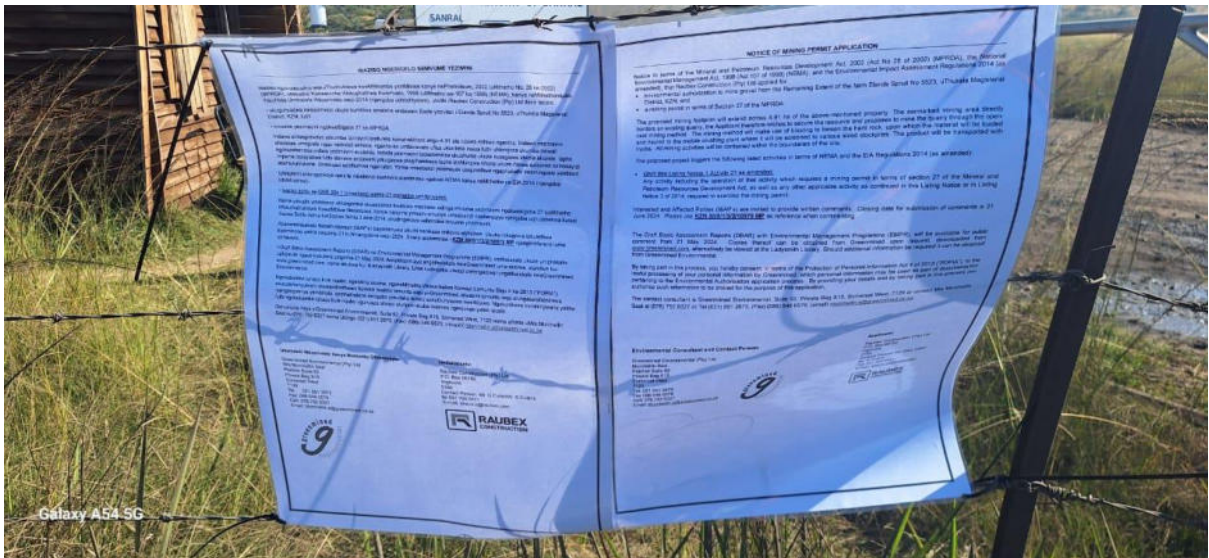

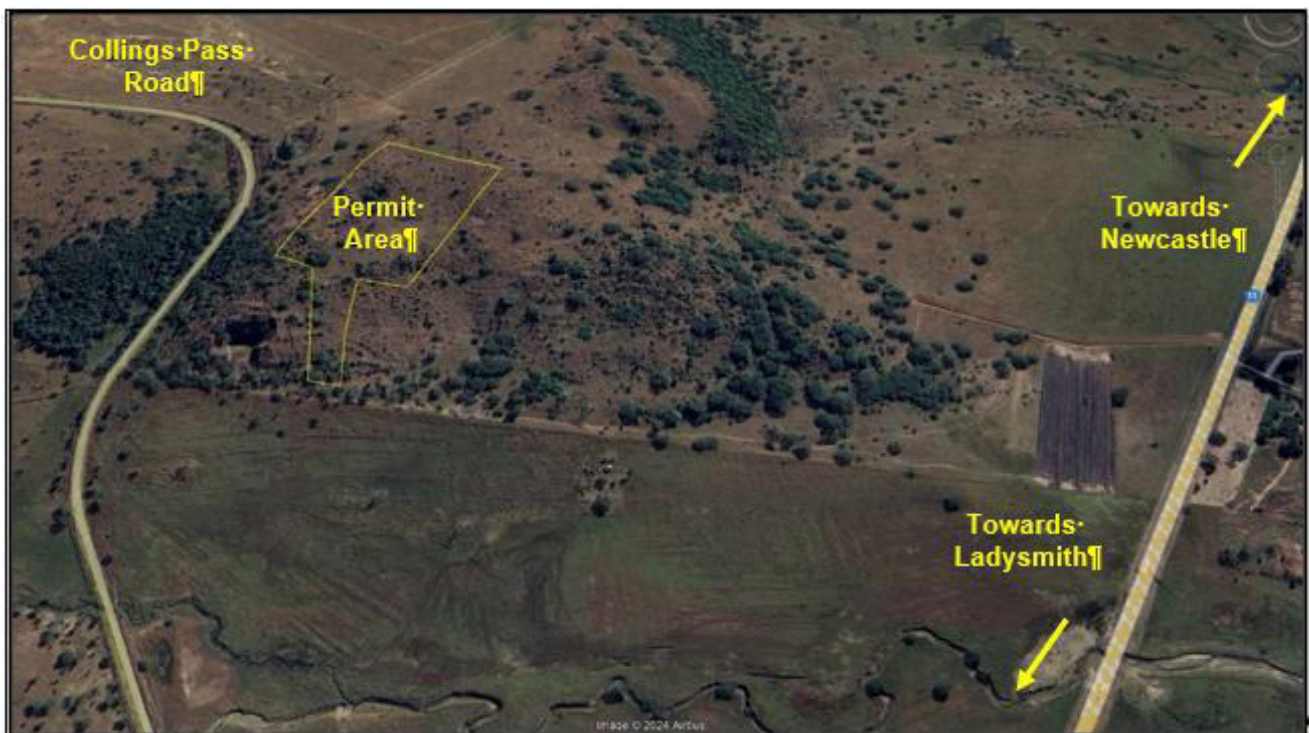

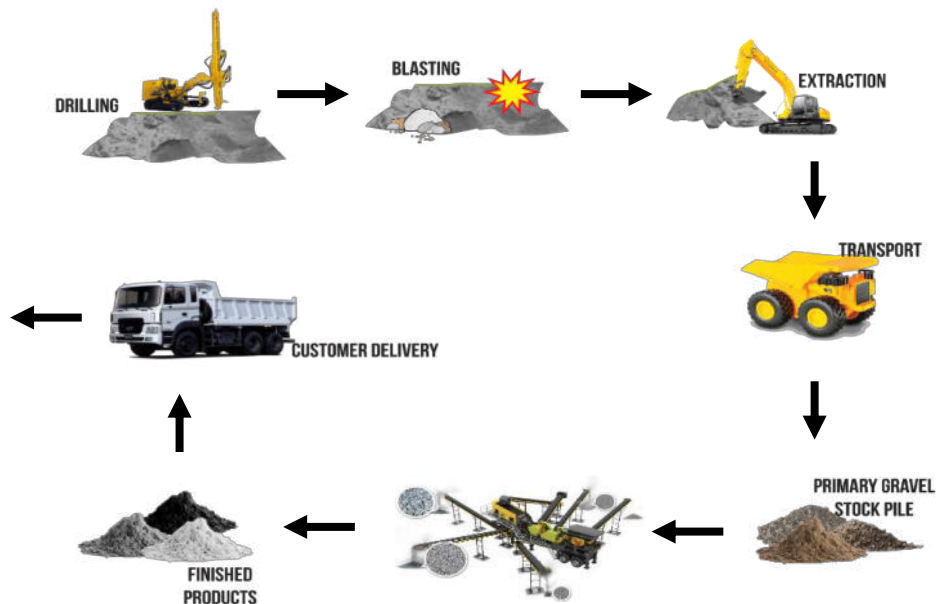

PROJECT PROPOSAL

Raubex Construction (Pty) Ltd applied for a gravel mining permit on 4.91 ha of the Remaining Extent of the farm Elands Spruit No 5523 in the uThukela Magisterial District of KZN. The property is ±26 km north-east of Ladysmith between Collings Pass Road and the N11 national road. The earmarked mining area directly borders an existing quarry, the Applicant therefore wishes to secure the resource and proposes to mine the quarry through the open-cast mining method.

The proposed mining method (as depicted below) will make use of blasting to loosen the hard rock; the material will then be loaded and hauled out of the excavation to the mobile crushing plant where it will be screened to various sized stockpiles. The material will be stockpiled until it is transported from site using trucks. The mine will be reached via the existing farm road that will be upgraded to allow comfortable movement of mining machinery. Water requirements will mainly be for dust suppression on the processing plant and access road. Any water required for the implementation of the project will be bought and transported to site. The proposed project will make use of generators to power the plant.
